

## Exhibition Participation Agreement

In order to create a good trade atmosphere at the exhibition site and effectively protect the intellectual property of enterprises and products, our company commits to the following for the duration of DOMOTEX asia/CHINAFLOOR 2019:

### I. One application form, one exhibiting company

1. In principle, each booth of the exhibition can be used only by the exhibiting company that signs the terms of participation with the organizer;
2. It is forbidden to resell the booth to a third party without permission from the organizer, or to display products unrelated to the exhibitor's own brand on the booth.

Once discovered the exhibitor will accept the organizer's decision (including but not limited to on-site closure of the booth, cancellation of the next edition of the exhibition qualification, cancellation of preferential policies, etc.).

### II. No items occupying the corridors

1. All exhibitors can only display their own products within their booths, and it is forbidden to occupy corridors and public areas to display products;
2. If the products are found to be outside the stand, the exhibitor will be asked to return the exhibits/products within the designated area. Serious or repeating cases will be dealt differently according to the organizer's decision and judgment (including but not limited to on-site confiscation of exhibits/products, on-site power cuts, etc.).

### III. Civilized participation, control of noise volume

1. Important events during the exhibition (including but not limited to celebrity visits, live conferences, etc.) need to be reported to the organizer before January 25, 2019. Only after obtaining the approval of the organizer, you can proceed with further arrangements.
2. Any volume played or produced during the exhibition shall not exceed 70 decibels (floor technology exhibition area is adjusted to below 90 decibels);
3. If the decibel on-site measurement exceeds the specified decibels, the exhibitor agrees that the organizer can take corresponding rectification measures (including but not limited to half-hour off, etc.).

### IV. Legal participation and respect for intellectual property

1. The exhibitor certifies that his company does not violate laws, rules and regulations related to intellectual property rights, and relevant international treaties/ conventions applicable in China;
2. Exhibiting exhibits that infringe the intellectual property rights of others and exhibits that are under administrative or judicial proceedings due to intellectual property disputes during the exhibition period is not accepted;
3. During the exhibition period, if there are exhibits that allegedly infringe on the intellectual property rights of others, it will be based on the organizer of the exhibition and/or the intellectual property administration to request that the judicial authorities verdict is accepted (including but not limited to withdrawing the infringing exhibits, destroying the publicity materials introducing the infringing exhibits, and replacing the introduction of infringement on exhibition boards, etc.);
4. Actively cooperate with the intellectual property administration authorities and judicial organs in the process of exhibition evidence collection, forensics, inquiries, etc., and cooperate with the organizers in other intellectual property-related matters.
5. The exhibitor agrees to bear all losses caused to the organizer due to infringement of the intellectual property rights of others.
